OFFICE ORDER

Terms of Reference

3. Interact regularly with students, especially fresh entrants, to create a ragging-free environment.
4. Promptly investigate complaints or information related to ragging and immediately report the matter to the Anti-Ragging Committee and the Principal for necessary action.
5. Coordinate with the Hostel Authorities, Security Personnel and Student Welfare Committee for effective monitoring.
6. Maintain proper records of inspections, observations and actions taken.

The members of the Squad shall perform their duties with utmost sincerity and ensure strict compliance with the provisions of the UGC Regulations, NMC guidelines and the Anti-Ragging Policy of the Institution.

This Office Order shall come into force with immediate effect until further orders.
